3. NATURE OF CLAIM

The claim is one founded in negligence, and is for personal injuries and death of the claimant's decedent, Bryan A. Willis.



4. This is a claim for money damages for personal injuries and wrongful death sustained by the claimant's decedent, Bryan A. Willis against the respondents when the vehicle claimant's decedent was operating was caused to crash after leaving Lakeshore Avenue in Dunkirk, Chautauqua County, New York as a result of the reckless and willful conduct by officers, agents, servants and employees of respondents.

This claim is for personal injuries and other damages sustained by Claimant as a result of the intentional, reckless and willful conduct; negligent hiring, negligent training, general negligence, vicarious liability and violations of the Federal Civil Rights Law, The United States Constitution, The New York State Constitution and the Amendments thereof.

- 5. The time when the claim arose and the time when injuries and damages herein alleged were sustained was October 15, 2015 at approximately 9:30 p.m. on Lakeshore Road East near North Ermine Street in Dunkirk, Chautauqua County, New York.
- 6. The incident occurred in the area commonly known as Lakeshore Road East near North Ermine Street in Dunkirk, Chautauqua County, New York.
- 7. That the cause of action which forms the substance of this claim arose in the following manner:

On or about October 15, 2015 at approximately 9:30 p.m., the vehicle claimant's decedent was operating was caused to leave Lakeshore Road East in Dunkirk, Chautauqua County, New York as a result of a high-speed chase by agents, servants and employees of the respondents, including, but not limited to, behavior that was reckless and willful by officers, agents, servants and employees of respondents, which conduct caused claimant's decedent's vehicle to crash into a vacant residence on Lakeshore Road East in Dunkirk, Chautauqua County, New York, resulting in injury and death.

8. The negligence and carelessness of the respondents, their agents, servants and employees consists, inter alia, in failing to follow proper protocol in place by the Uniform Vehicle Code and proper protocols and procedures; in pursuing a vehicle at a high rate of speed throughout a residential neighborhood; in failing to exercise due regard for the safety of all persons; in operating said vehicles in a reckless manner with total disregard for the safety of others; in



discharging a weapon without just cause; in causing claimant's decedent to leave the roadway and crash into a vacant residence; in negligently and recklessly failing to adopt and follow a restrictive pursuit policy; in negligently and recklessly initiating a high-speed pursuit; in failing to terminate such high-speed pursuit; that the agents, servants and employees of respondents used conduct, made decisions and initiated tactics which caused the claimant's decedent's wrongful death; in failing to initiate departmental training and controls for pursuits of persons, such as the claimant's decedent; in failing to provide emergency vehicle operation training and driving courses; in failing to adequately supervise their agents, servants and employees; in failing to adequately supervise the pursuit; in failing to properly investigate the initiating event; in causing and allowing a dangerous condition to exist and failed to take the necessary steps and make the necessary observations which, if taken or made, would have avoided the said incident; and that the respondents, their agents, servants and/or employees were otherwise negligent.

9. That as a result of the acts complained of, the claimant's decedent, without limitation, was caused to suffer physical injuries and death; to receive medical aid and attention, to have conscious pain and suffering and emotional anguish and fear of impending death. The full extent of the injuries are not known at this time and the exact amount of such expenses for medical retention and other damages cannot be determined at the present time.
