Since my office is outside the radius which had been notified of the hearing which was held Tuesday evening, I appreciate this opportunity to respectfully submit my thoughts on the matter. Those thoughts are as follows:

First, I would concur with Ms. Tower that because of all that the Historical Society and the Academy Heights folks have been doing to beautify the City, it would be a shame to erect another large, commercial sign in an area that welcomes us to a historic district.

Therefore, could the sign be re-designed to (1) be of a size and design commensurate with the existing sign for Brooks Hospital, and (2) to incorporate the old carriage block and hitching post if they are not already a permanent part of the new landscape?

As residents of the historic Academy Heights Neighborhood, we are opposed to the sudden emergence of a plan to erect a billboard sized lighted sign at the corner of fifth and Central. This is not compatible with our neighborhood, diminishes the name of the family Brooks who donated their house and their land for this very hospital. There is already a classy sign in front of the hospital. At no time have we been informed that a huge contemporary sign was to be part of the parking lot development. As two active neighborhood groups, Washington Park, which is adjacent to the hospital as well as Academy Heights in whose neighborhood the hospital resides, we would be expected to be consulted regarding any such plan and the values of this neighborhood taken into consideration. To consult a small sampling of homes and have no one show up for zoning is not an appropriate step in seeking positive relationships with a community. We request a delay in the plans and a thorough review of the plans so that these concerns can be
