Joel Biscaro, 11 Pennsylvania Avenue, Dunkirk, New York was sworn in and testimony was taken in favor of the Board granting this appeal.

Lawrence Thompson, 14 Wilson Avenue, Dunkirk, New York, surrounding property owner, questioned the construction of the garage addition.

for permission to install four signs (tobacco free) at entrances of Brooks Memorial Hospital. Not in

compliance with Article XXI, Section 79-21040(7)(a) and (b) of the Zoning Code of the City of Dunkirk, New York.

## **DETERMINATION**

## **APPEAL #2012-06**

In the appeal of Joel & Charlene Biscaro it was the unanimous decision of the Board that this appeal be granted with the following stipulations:

- 1. The appellant must comply with all testimony and information presented at the Zoning Board of Appeals meeting held 5/22/12.
- 2. All state and local building codes shall be followed.
- 3. Drainage shall be reviewed by the Building Inspector.

- 2. This addition is an addition of an existing non-conforming structure.

## **APPEAL #2012-07**

In the appeal of Brooks Memorial Hospital it was the unanimous decision of the Board that this appeal be granted with the following stipulations:

- 1. The appellant must comply with all testimony and information presented at the Zoning Board of Appeals meeting held 5/22/12.
- 2. One sign per entrance only, with a maximum of four signs.

The Board stated the following finding of fact in their determination:

1. The appellant is attempting to enhance the tobacco free policy for the public.
