Vendor is responsible for clean-up, including removal of all debris, no later than 10:00 a.m. on Monday, June 20, 2016.

Vendor fees: June 17 \$100.00, June 18 \$100.00, June 19 \$100.00; entitling Vendor to a pre-determined, reserved location measuring fifteen feet (15') frontage. Set-ups requiring greater than fifteen feet (15') frontage will require application for additional space(s).

Vendor is solely responsible for the means and manner of all such activities contemplated hereunder and shall be solely responsible to insure compliance with each and every applicable rule, regulation, law and/or requirement. The City makes no warranties, either express or implied, with regards to the goods and/or services sold by the Vendor.

Vendor must comply with each and every rule, regulation, law and requirement imposed by any appropriate federal, state and local authority, including but not specifically limited to the NYS and County of Chautauqua Departments of Health. All statutory provisions applicable hereto are hereby incorporated by reference.

Vendor shall provide to the City before set-up appropriate proof of general comprehensive liability insurance naming the City as an additional insured, in an amount no less than \$1,000,000.00 (Vendor Classification E of the City of Dunkirk Standard Insurance Certificate).

Vendor shall, in addition to the other requirements hereunder, indemnify and insure the City against any and all claims, costs and damages arising out of the performance or non-performance of activities contemplated hereunder.

Approval of this Application in no way confers any permanent legal right, title or interest in or to any property; approval and use by the Vendor of any such property does not and shall never ripen into or become a right to own or to use any portion of the premises in a manner inconsistent with the terms herein. Upon approval, the Vendor shall have a non-exclusive, revocable right to use the premises solely upon the terms and conditions contained herein.
