### RULES FOR EXAMINATION

1. Examinations shall consist of applicant's knowledge of practical electrical work and knowledge of the current National Electrical Code.
2. All persons desiring to be examined for a Master Electrician's License shall have application, required documents and fee on file at least thirty (30) days prior to the date of such examination.
3. A passing grade of at least 70% will be required in order to obtain a license. Applicants who fail to obtain the required 70% will not be entitled to re-examination until a period of three (3) months from date of failure. Applicant who fails twice shall not be further eligible for re-examination until after one (1) year from the date of such second or subsequent failure.
4. Any person found referring to notes or books except for the current edition of the National Electric Code, or misbehaving during an examination will be debarred from that examination for a period of one (1) year.
5. Application for license must be signed by a qualified individual as defined in Chapter 28, as amended, Electrical Installations of the City Code of Dunkirk and must be the individual who will take the examination.
6. Applicants will be notified of the time and place of the examination.
7. All questions unanswered at the expiration of the examination period shall be counted as zero.

### WAIVER OF EXAMINATION:

1. Complete application, include copies of current license/s for municipalities with population of 15,000 or greater, include Certificate of Insurance naming 'holder' as "City of Dunkirk", and include fee.
